

THINGS TO KNOW BEFORE CLOSING

B U Y E R T I P S

- ▶ Provide a copy of current U.S. Government Issued Picture ID (Drivers License / ID Card , US Passport, US Military ID, or a Mexican Passport)
- ▶ Provide fully completed Customer Information Sheet
- ▶ Provide marital status and spouse information and ID Lender contact information
- ▶ Copies of formation documents, active standing certificate, and resolution, to review, if not purchasing the property individually as natural persons
- ▶ Notice to Valley Land Title Co. if you are related to the Seller(s)
- ▶ Copy of a Current Certification of Trust or full Copy of Trust and any amendments to the Trust (if applicable)
- ▶ Advance notice if you will not be signing in person at Valley Land Title Co. and mobile notary arrangements or Remote Online Notary arrangements and appointments need to be made
- ▶ Bring in certified funds or proof of wire transfer payable to Valley Land Title Co. to closing
- ▶ Residential Warranty Invoice
- ▶ Survey and Survey Invoice, if buyer to secure under the Contract
- ▶ Power of Attorney, if a Power of Attorney will be used, to review prior to closing to see if acceptable

SELLER TIPS



- ▶ Provide a copy of current U.S. Government Issued Picture ID (Drivers License / ID Card , US Passport, US Military ID, or a Mexican Passport)
- ▶ Provide fully completed Customer Information Sheet
- ▶ Provide Marital Status from the date property was acquired thru the present time; if any changes in Marital Status, supporting documents to review (ie, divorce decrees, probate document, etc.)
- ▶ Provide current mortgage information and written authorization to allow Valley Land Title Co. to secure a payoff statement
- ▶ Provide last 4 numbers of social security number (The full social security number will be required at closing for 1099 IRS reporting)
- ▶ Immediate notice to Buyer, Buyer's agent and Valley Land Title Co. if you are a Foreign National
- ▶ Copy of existing survey and T-47 Survey Affidavit, if you have agreed to provide under the contract
- ▶ Copies of formation documents, active standing certificate, and resolution, to review, if not selling individually as natural persons
- ▶ Copy of a Current Certification of Trust or full Copy of Trust and any amendments to the Trust, if hold title as Trustee of a Trust
- ▶ Advance notice if you will not be signing in person at Valley Land Title Co. and mobile notary arrangements or Remote Online Notary arrangements and appointments need to be made
- ▶ Power of Attorney, if a Power of Attorney will be used, to review prior to closing to see if acceptable
- ▶ Your wiring instructions, if you will be requesting net proceeds of sale in the form of a wire to your bank
